Carnedd Wen Wind Farm Fferm Wynt Carnedd Wen

Invitation to Public Information Sessions

RWE is developing a revised proposal for the Carnedd Wen Wind Farm, located in Llanbrynmair Forest in north-west Powys.

The proposal is at an early stage and a layout of 28 wind turbines with a maximum tip height of 200m is currently being considered (an installed capacity of approximately 184MW). With the benefit of consultation and further environmental studies, the design will evolve, with the number of turbines subject to change.

Both the Welsh Government and Powys County Council have declared a climate emergency and Carnedd Wen Wind Farm would make a significant contribution towards achieving the Welsh Government's target of being net zero by 2050. Alongside the benefits of renewable energy, the project is also exploring opportunities for peatland restoration. RWE will also invest in local communities through offering a community benefits package and is open to considering shared or local ownership models.

Gwahoddiad i Sesiynau Gwybodaeth i'r Cyhoedd

Mae RWE yn datblygu cynnig diwygiedig ar gyfer Fferm Wynt Carnedd Wen, wedi'i lleoli yng Nghoedwig Llanbrynmair yng ngogledd-orllewin Powys.

Mae'r cynnig yn ei gyfnod cynnar ac mae cynllun o 28 tyrbîn gwynt gydag uchafswm uchder hyd at flaen y llafnau o 200m yn cael ei ystyried ar hyn o bryd (capasiti gosodedig o tua 184 MW). Drwy fanteisio ar ymgynghoriad ac astudiaethau amgylcheddol pellach, bydd y dyluniad yn esblygu, a gallai nifer y tyrbinau newid.

Mae Llywodraeth Cymru a Chyngor Sir Powys wedi datgan argyfwng hinsawdd. Byddai Fferm Wynt Carnedd Wen yn gwneud cyfraniad sylweddol tuag at gyflawni targed Llywodraeth Cymru o fod yn sero net erbyn 2050. Ochr yn ochr â manteision ynni adnewyddadwy, mae'r prosiect hefyd yn archwilio cyfleoedd i adfer mawndiroedd. Bydd RWE hefyd yn buddsoddi mewn cymunedau lleol trwy gynnig pecyn buddion cymunedol ac mae'n agored i ystyried modelau rhanberchnogaeth neu berchenogaeth leol.

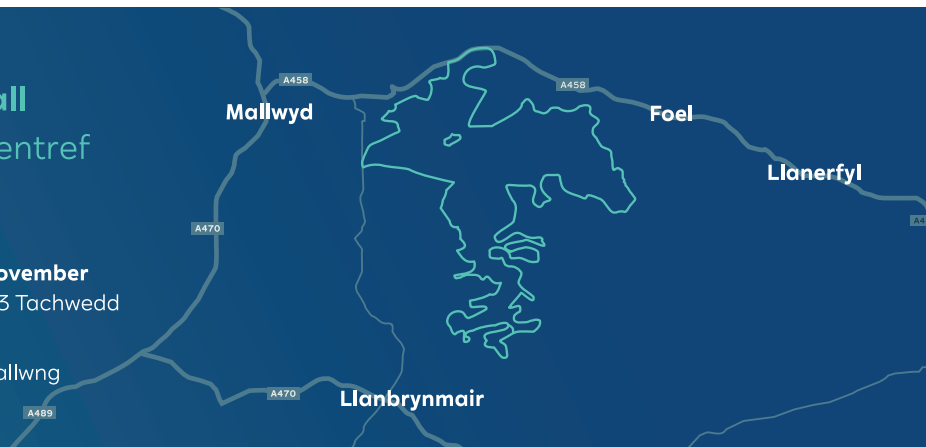
