### Turbine Component Deliveries & Parking Restrictions

Dear Resident,

**We realise that the component deliveries will affect the surrounding community. We apologise in advance for any potential delays and inconvenience this may cause, and we would like to express our sincere thanks once again for your continued cooperation.**

As you may be aware, deliveries of turbine components for Enoch Hill Wind Farm commenced on August 9th. The delivery of the larger components (including the turbine blades) is scheduled to begin on or around August 28th. These delivery vehicles will require more road space than the tower components you may have previously seen passing through.

In our July newsletter, we notified residents along our component delivery route of the Temporary Traffic Regulation Orders (TTROs) that we are required to have in place for the duration of the deliveries, as part of the abnormal road permit. TTROs are legal orders that require certain areas of public road space to be kept clear to allow the delivery vehicles to pass safely. TTROs are in place in the three following areas (maps overleaf):

- 1 A76 Pathhead, New Cumnock (Figure 01)
- 2 A76/B741 Afton Bridge, near New Cumnock Primary School (Figure 02)
- 3 B741, Connel Burn (Figure 03)

The TTROs are in force from July 3rd, 2024 until February 28th, 2025. Cones will be placed in the relevant areas to prevent parking and obstruction; however, they will be removed during periods when deliveries are not scheduled to minimise disruption.

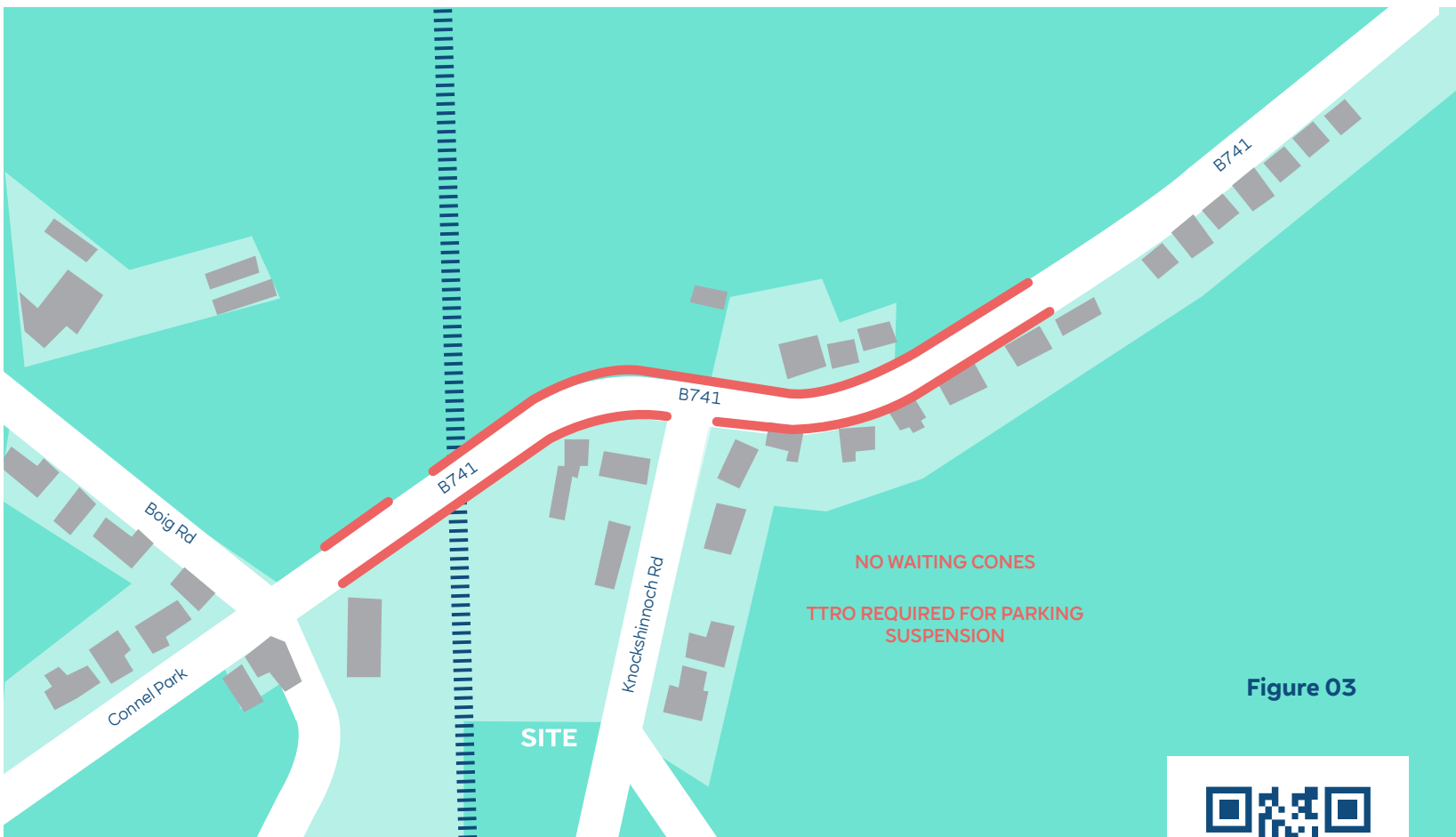
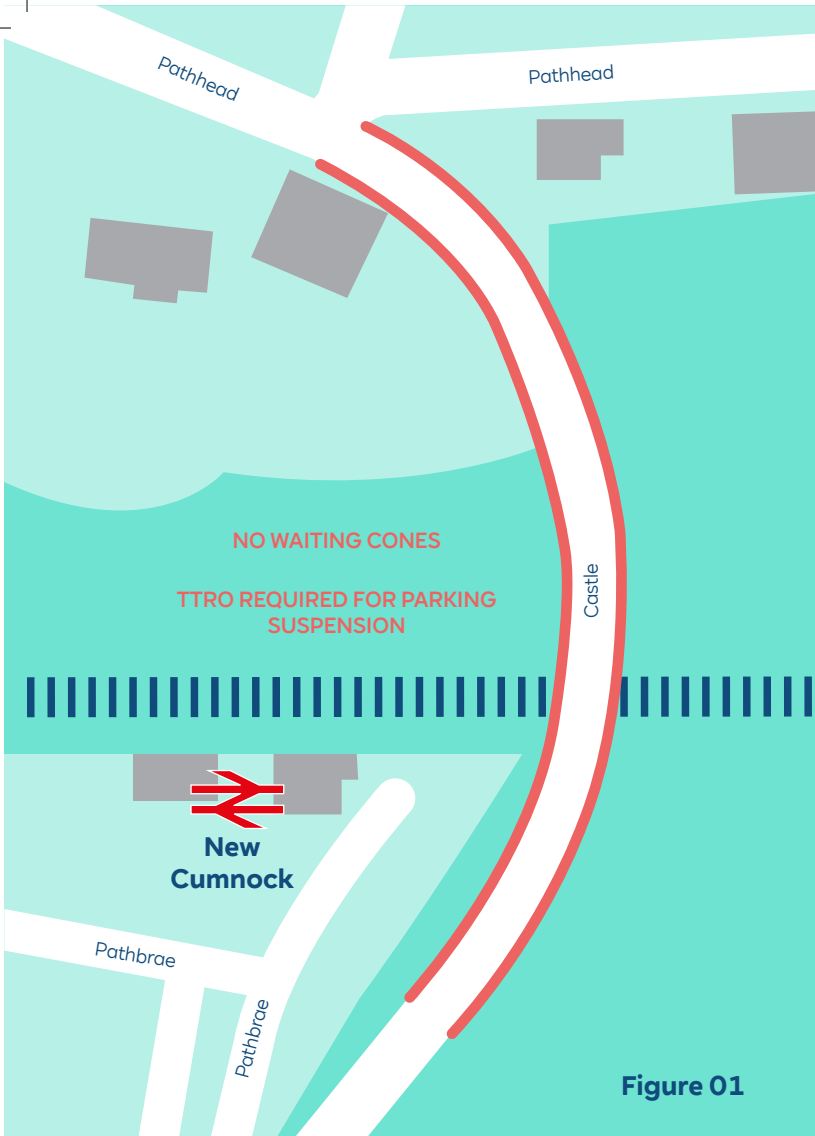
We would like to remind all residents and road users of the map location and details of the TTROs, and kindly request the following to ensure our ALL vehicles pass safely through the area:

- Please do not move or tamper with the cones that have been placed in the outlined locations.
- Please refrain from parking on the pavement adjacent to the cones. The cones are there to prevent parking on both the road and the pavement during delivery periods.

Parking on a footway is illegal. We have had several incidents where the police have had to knock on doors and request vehicles be moved to allow the convoy to pass safely. To minimise disturbance to residents, we ask for your cooperation.

We are also conducting monthly video and photographic surveys of the delivery route, as required by Ayrshire Roads Alliance (ARA), to monitor the condition of the roads during the delivery period. This includes roads, bridges, culverts and structures close to the road, extending up to the site entrance. We wish to inform local residents so that you are aware should you see these surveys being carried out.
