

## Fund Development Case Study – Gwynt y Môr Offshore Wind Farm, N Wales

innogy adopted a multi stakeholder, partnership approach to developing the Gwynt y Môr Community Fund which will invest in the region of £19 million over the offshore wind farms lifetime. An advisory group, with members from the public, private, education and training, and voluntary sectors, pooled their expertise and local knowledge to develop the very best structure and delivery mechanism for the fund, building on the feedback from the community consultation on the fund. This partnership approach resulted in a bespoke fund - tailored to address funding gaps and build on successful existing funding practices - thus ensuring maximum impact from these new, flexible funds which have the potential to deliver well beyond their original £19 million investment.

### Stage 1 – Engaging the wider community

In February 2012 innogy listened to the views of over 1000 organisations and individuals on the potential priorities, structure and operation of the Gwynt y Môr Community Fund. The consultation focused on what priorities the fund should address, how it should be managed and which communities should benefit.

### Stage 2 – The Advisory Group

innogy convened an Advisory Group of local stakeholders, representing the broad North Wales area to provide advice and expertise to support innogy to take forward the results of the consultation and to develop a fund structure. The group also explored how our funding will work alongside other funding streams and activities to achieve a more joined up approach to funding. Membership of the group included representatives from the Local Authority and Voluntary Sector from each of the three counties (Conwy, Denbighshire and Flintshire) as well as representatives from Higher Education sector, social enterprise and the business sector. The Advisory Group met at monthly intervals and notes from their meetings were shared on innogy’s website to ensure transparency.



### The initial agreed fund themes are:

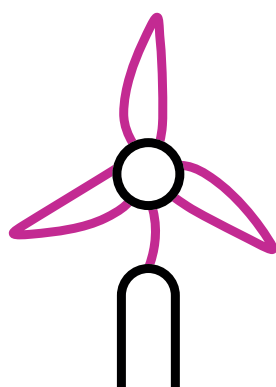
**Theme 1** – Building strong, cohesive and sustainable communities

**Theme 2** – Developing prosperous, enterprising communities with strong economic growth

**Theme 3** – Reducing poverty and inequality in communities

### Stage 3 – Fund Administration

We completed an open procurement process to identify a suitable organisation to manage the fund. This unusual and exciting opportunity received a high level of interest from a range of organisations. The tender opportunity was advertised in the local media, and Gwynt y Môr received 12 expressions of interest and eight full tender submissions. Following a rigorous interview process we were delighted to appoint Community & Voluntary Support Conwy (CVSC) working in co-operation with Denbighshire and Flintshire Councils for Voluntary Services. ## Datblygu Cronfa - Astudiaeth Achos: Fferm Wynt Alltraeth Gwynt y Môr, Gogledd Cymru

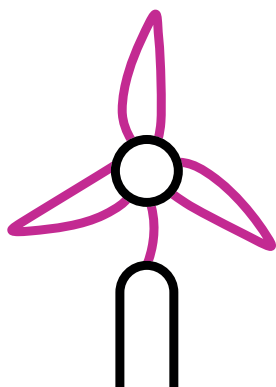
Mabwysiadodd innogy ddull partneriaeth gyda nifer o randdeiliaid wrth ddatblygu Cronfa Gymunedol Gwynt y Môr a fydd yn buddsoddi oddeutu £19 miliwn dros oes y fferm wynt alltraeth. Aeth grŵp cynghori, gydag aelodau o'r sectorau cyhoeddus, preifat, addysg a hyfforddiant a'r sector gwirfoddol ati i gydgyfrannu eu harbenigedd a'u gwybodaeth leol i ddatblygu'r strwythur a'r dull cyflawni gorau posib ar gyfer y gronfa, gan adeiladu ar yr adborth a gafwyd o'r ymgynghoriad cymunedol ar y gronfa. Esgorodd y bartneriaeth hon ar gronfa bwrpasol, oedd wedi'i theilwra i roi sylw i fylchau mewn cyllid ac i adeiladu ar arferion cyllid llwyddiannus oedd yn bodoli eisoes, gan sicrhau bod y cronfeydd newydd, hyblyg hyn yn cael yr effaith fwyaf bosib a'u bod yn gallu darparu ymhell y tu hwnt i'r buddsoddiad gwreiddiol o £19 miliwn.

### Cam 1 - Ennyn diddordeb y gymuned ehangach

Yn mis Chwefror 2012, gwrandawodd Innogy ar sylwadau dros 1000 o sefydliadau ac unigolion ar flaenoriaethau, strwythur a gweithrediad posib Cronfa Gymunedol Gwynt y Môr. Roedd yr ymgynghoriad yn canolbwyntio ar ba flaenoriaethau y dylai'r gronfa roi sylw iddynt, sut y dylid ei rhedeg a pha gymunedau a ddylai gael budd ohoni.

### Cam 2 - Y Grŵp Cynghori

Casglodd Innogy Grŵp Cynghori at ei gilydd o blith rhanddeiliaid lleol oedd yn cynrychioli ardal Gogledd Cymru i roi cyngor a chynnig arbenigedd i gefnogi Innogy gyda'r gwaith o ddatblygu canlyniadau'r ymgynghoriad a llunio strwythur ar gyfer y gronfa. Bu'r grŵp hefyd yn archwilio sut y bydd ein cyllid yn gweithio ochr yn ochr â gweithgareddau a ffrydiau cyllido eraill er mwyn sicrhau dull mwy cydgyssylltiedig o gyllido. Roedd aelodaeth y grŵp yn cynnwys cynrychiolwyr o Awdurdod Lleol a Sector Gwirfoddol pob un o'r tair sir (Conwy, Sir Ddinbych a Sir y Fflint) yn ogystal â chynrychiolwyr o'r sector Addysg Uwch, mentrau cymdeithasol a'r sector busnes. Cyfarfododd y Grŵp Cynghori unwaith y mis a rhannwyd nodiadau o'r cyfarfodydd ar wefan Innogy er mwyn sicrhau tryloywder.



### Dyma'r themâu cychwynnol y cytunwyd arnynt ar gyfer y gronfa:

- Thema 1** – Creu cymunedau cryf, cydlynus a chynaliadwy
- Thema 2** – Datblygu cymunedau ffyniannus a mentrus gyda thŵf economaidd cryf
- Thema 3** – Lleihau tloedi ac anghydraddoldeb mewn cymunedau.

### Cam 3 – Gweinyddu'r Gronfa

Roeddem wedi cynnal proses gaffael agored i ganfod sefydliadau addas i redeg y gronfa. Roedd amrediad o sefydliadau wedi dangos llawer iawn o ddiddordeb yn y cyfle anarferol a chyffrous hwn. Hysbysebwyd y cyfle i dendro yn y cyfryngau lleol, a derbyniodd Gwynt y Môr 12 datganiad o ddiddordeb a chyflwynwyd wyth cais am dendr llawn. Yn dilyn proses gyfweled fanwl pleser o'r mwyaf i ni oedd penodi Cymorth Gwirfoddol a Chymunedol Conwy yn cydweithio â Chynghorau Gwasanaethau Gwirfoddol Sir Ddinbych a Sir y Fflint.
