AND UPON READING the Witness Statements of Rachel Jane Smith dated 1 October 2025 and William Henry Jeffery dated 1 October 2025

AND UPON HEARING Timothy Morshead KC and Jacqueline Lean for the Claimant

AND UPON the Claimant giving and the Court accepting the undertakings set out in Schedule 1 to this Order

IT IS ORDERED THAT:

INJUNCTION

Until the return date or further order of the court:

- 1. The Defendants must not enter, occupy or remain on, or damage or deface any part (including the perimeter fence), of the land and premises shown edged red on Plans 1 to 6 to this Order, being:
 - (i) Staythorpe Power Station, Staythorpe, Newark, NG23 5RQ, as shown edged red on Plan 1;
 - (ii) Didcot Power Station, Didcot, Oxfordshire, OX11 7YU, as shown edged red on Plan 2;

- (iii) Pembroke Power Station, Pembroke, West Pennar, Dyfed, SA71 5SS, as shown edged red on Plan 3;
- (iv) Little Barford Power Station, Little Barford, St Neots, Huntingdon, Cambridgeshire, PE19 6YT, as shown edged red on Plan 4;
- (v) Great Yarmouth Power Station, , South Denes Road, Great Yarmouth, NR303PY, as shown edged red on Plan 5.
- (vi) Kings Lynn Power Station, Kings Lynn, PE34 3RD, as shown edged red on Plan6.
- 2. In respect of anything prohibited by paragraph 1 above, the Defendants must not (a) do it himself/herself/themselves in any other way or (b) do it by means of another person acting on his/her/their behalf, or acting on his/her/their instructions.

THE RETURN DATE

- 3. The application for an interim injunction having been made without notice to the Defendants, the application be listed for a return date of 24 October 2025 with a time estimate of 2 hours.
- 4. The Defendants may file and serve any evidence in response by 17 October 2025. Skeleton Arguments shall be filed at Court, with a bundle of authorities, not less than 2 days before the hearing.

SERVICE AND NOTIFICATION

- 5. Service of the Claim Form, the Application for interim injunction and this Order on the First Defendant is dispensed with, pursuant to CPR 6.16, 6.28 and 81.4(2)(c).
- 6. The Claim Form, Particulars of Claim, Application Notice, evidence in support and a Note of the Hearing on 3 October 2025 will be notified to the First Defendants by the Claimant carrying out each of the following steps:

- (i) Uploading a copy on to the following website: https://uk.rwe.com/injunction
- (ii) Affixing notices at prominent locations at each of the Sites shown edged red on Plans 1 to 6 setting out where these documents can be found and obtained in hard copy or including this information in the warning notices referred to at paragraph 7 below.
- 7. This Order shall be notified to the First Defendants by the Claimant carrying out each of the following steps:
 - (i) Uploading a copy of the Order on to the following website: https://uk.rwe.com/injunction
 - (ii) Affixing a copy of the Order in A4 size in a clear plastic envelope at prominent locations at each of the Sites shown edged red on Plans 1 to 6.
 - (iii) Affixing warning notices of A2 size at those locations at each of the sites shown edged red on Plans 1 to 6, substantially in the form of the notice at Schedule 3.
- 8. Notification to the First Defendants of any further applications shall be effected by the Claimants carrying out each of the following steps:
 - (i) Uploading a copy of the application on to the following website: https://uk.rwe.com/injunction
 - (ii) Affixing notices at or near the aforesaid prominent locations at the relevant Site/s shown edged red on Plans 1-6, stating that the application has been made and where it can be accessed in hard copy and online.
- 9. For the avoidance of doubt, in relation to notification to the First Defendant of the return date ordered at paragraph 3 above, the steps indicated in paragraph 7 above are sufficient without further steps pursuant to paragraph 8 above regardless of

- whether any listing or other application must be made in order to give practical effect to bringing the hearing on pursuant to paragraph 3 above.
- 10. Notification of any further documents to the First Defendants may be effected by carrying out the steps set out in paragraphs 6(i) and 6(ii) only.
- 11. In respect of paragraphs 6 to 10 above, effective notification will be deemed to have taken place on the date in relation to each Site on which all the relevant steps have been carried out.
- 12. For the avoidance of doubt, in respect of the steps referred to at paragraphs 6(ii), 7(ii), 7(iii), and 8(ii), effective notification will be deemed to have taken place when the documents have all been first affixed regardless of whether they are subsequently removed or defaced without the Claimant's consent.
- 13. The Claimant shall use reasonable endeavours to maintain and as the case may be replace the documents in their fixed positions and in legible form.
- 14. In relation to the Second Defendant: pursuant to CPR rules 6.15 and 6.27, the Claimant has permission to serve the Second Defendant with the Claim Form, Particulars of Claim, Application for interim relief, evidence in support of the Claim and Application, this Order and any further applications or documents in the Claim by email to:

- 15. The deemed date of service of any documents referred to in paragraph 14 above shall be the day on which service of the document or documents is completed in accordance with paragraph 14 above.
- 16. Any acknowledgment of service by the Second Defendant is to be filed and served by 24 October 2025.

17. The Claimant shall use reasonable endeavours to notify the owners (where known) of the areas of land shown hatched blue on Plans 1A, 2A,4A, 5A and 6A at Annexure 2 to the Particulars of Claim of the claim, the application for an injunction and this Order by not later than 5pm on 7 October 2025.

VARIATION

- 18. Anyone interested may apply to the Court at any time to vary or discharge this Order or so much of it as affects that person but they must first give the Claimant 48 hours' notice of such application. If any evidence is to be relied upon in support of the application the substance of it must be communicated in writing to the Claimant at least 24 hours in advance of any hearing.
- 19. Any person applying to vary or discharge this Order must provide their full name, address and address for service.
- 20. The Claimant has liberty to apply to vary this Order.






SCHEDULE 1 – UNDERTAKINGS




